"Move that the student who was the subject of this hearing shall be expelled from all school properties and school sponsored events through September 14, 2019, notwithstanding the foregoing, the student can return to school on November 1, 2018, on probationary status, and thereafter remain in school if the Student meets the following conditions set for in the stipulated agreement, jointly presented by both parties:

- The Student is not permitted to be on school grounds or to attend any schoolsponsored activity, whether that activity is academic, athletic, social or otherwise. However, the Student may come onto school grounds if it is necessary to attend the Student's alternative education or if the Student has the written permission of the Superintendent.
- During the Expulsion Period, the Student shall receive an alternative educational program to be provided by the Administration, in accordance with the law.
- The Student actively participates in the alternative education
- The Student must not commit another suspendable or expellable offense
- Prior to readmission, the Student undergoes a risk assessment by a competent medical professional, either by District affiliated personnel or (at the Parents' expense) a professional of the Parents' choosing
- By September 15, 2019, the Student performs 80 house of community service at a location or activity previously approved by the Superintendent; said community service may be applied towards any applicable High School credit requirements
- The Student continues to participate in a program of counseling (at the family's expense) that is satisfactory to the Administration. The parents shall provide any and all releases and consent so that the Administration may communicate with the Student's medical treaters, including any mental health professionals or counselors, as may be requested
- Upon the Student's return, the Student will be required to meet weekly with a school counselor in order to monitor her progress in school and in complying with the terms of the stipulated agreement
- Upon the Student's return, the Student shall participate in a restorative process with respect to those students and staff members referenced in the "list" that is satisfactory to the Administration, to ensure the Student's successful re-

integration in the High School community and to provide comfort to those individuals referenced in said list.
